Message from Matthew

I hope you share my excitement about the news of announcing our first contractor, it's a milestone for the building of the Third Crossing!

I wanted to take you behind the scenes at the council, to tell you about some of the work that has happened for us to reach this important stage of the process. We have been working on the project since 2015 and now have a core team of six people.

They work with numerous of organisations and authorities to consider a variety of impacts ranging from wildlife, noise, street lighting, highways, pollution and landscaping to name but a few.

There is an incredible amount of detail required for a project like this, just the initial submission to apply for the Development Consent Order consisted of over 25,000 pages being delivered to the government's Planning Inspectorate. Tasks that need to be considered range from the structural design of the beam which gives the crossing its shape, to the fastenings required to secure litter bins in the surrounding landscape.

The team's hard work has resulted in Suffolk County Council's cabinet approving BAM Nuttall as the contractor to finalise designs for the crossing. Their bid brings a balance of high quality work and value for money.

Stage 1 - Contractor announcement What does this mean?

Suffolk County Council has announced that leading civil engineering contractor, BAM Nuttall, has won the contract for the first stage of completing the Lake Lothing Third Crossing in Lowestoft. The contract started on 1 November 2018.

Following a comprehensive tender process and approval by Suffolk County Council's cabinet, BAM Nuttall will now finalise the design of the crossing, ready for building. The award of the construction stage of the contract (Stage 2), is scheduled to be announced in the Autumn of 2019.

As project manager for the Lake Lothing Third Crossing at Suffolk County Council, it is my responsibility to manage the council's team and to liaise with the many partner organisations involved.

With BAM Nuttall's contract having begun on 1 November 2018, I will also be working closely with our colleagues there, to ensure the project progresses according to plan. An important part of this work will be to keep local residents and businesses updated with news and developments. We will do this with further editions of this newsletter and updates in the local news.

I also have regular meetings with local authorities and agencies supporting us in the process, such as WSP, who are leading engineering consultants and have been advising on the project since 2015.

Introduction to SHARP

Recommendation

Jun to Sep 2019

The Planning Inspectorate must prepare a report on the application to the relevant Secretary of State, including a recommendation, within three months of the close of the Examination.



Decision

Sep to Dec 2019

The relevant Secretary of State has three months to make the decision on whether to grant or refuse development consent.



Post-decision

Dec 2019 to Jan 2020

Once a decision has been issued by the relevant Secretary of State, there is a six week period in which the decision may be challenged in the High Court.

What happens now?

EXAMINATION

The Government's Planning Inspectorate will carry out the Examination of the application to build the crossing. This process will begin on the afternoon of 5 December 2018 and will last for six months. There will be several opportunities for people to provide more details of their views on the project during this time.

The Planning Inspectorate has appointed the Examining Authority to carry out the Examination. This LLTC panel will comprise of two independent Inspectors. At the end of this six month period, they will make their recommendation to the Secretary of State, who will decide whether to grant permission by December 2019.

PRELIMINARY MEETING

(5 DECEMBER 2018, 10AM)

The purpose of the Preliminary Meeting is to enable views to be put to the Examining Authority about the way in which the application is to be examined. At this stage the panel is looking at the procedure and not the merits of the application. Registered Interested Parties will be invited to attend.

OPEN FLOOR HEARING 1

(5 DECEMBER 2018, 2PM)

The purpose of an Open Floor Hearing is to allow Interested Parties to address the Examining Authority on relevant matters of their choosing. Speaking time will be shared between Interested Parties who have registered in advance. Parties who do not register in advance may be heard at the end of the hearing if there is time available and at the discretion of the Examining Authority.

The Preliminary Meeting and Open Floor Hearing 1 will be held at The Ivy House, Ivy Lane, Oulton Broad, Lowestoft NR33 8HY on Wednesday 5 December 2018.

NEXT STEPS

(5 DECEMBER 2018 TO 5 JUNE 2019)

There will be several more hearings during the Examination. Deadlines, hearings and meetings will be advertised on the Planning Inspectorate website, the Lake Lothing Third Crossing website, in the local media and in local venues.


